Dear Colleagues,

I begin by conveying my gratitude to the DGCA for giving IATA accredited travel agents all over India a huge respite, when it passed in its order dated 5th March, 2010, that airlines operating in India will have to necessarily commission to its travel agents.

I also wish to express a big thank you to all members of our association for being patient in all these months for such a verdict. These challenges that we confronted have taught us many things like using the tools of dialogue and consensus-building and applying a political principle that is one of the most basic, but also one of the most difficult to put in practice: that which says "in unity there is strength".

In continuation of this order, an all India associations meet was held in Mumbai on 5th April to discuss the way forward which was well attended. You can read all about it in this issue of newslines.

The latest hurdle to hit our industry was the volcanic ASH from the volcanic eruption in Iceland that spread through the skies the world over specially in the UK and other European countries and created havoc with flight passengers who were stranded in many airports. What can one do in the face of such a natural disaster?

Airlines are still going through a difficult time rescheduling flights as over 40,000 pax were affected. Distinguished Air Ambassadors and their Delegates were debating a change in the traditional approach to the concept of safety of flying in such conditions not to mention the hazards of security. What with the international panorama changing, and yesterday's strategic paradigms for security policy no longer suffice to manage the realities of today.!



We are all vulnerable to natural disasters, sensitive to ecological change, and in many cases, economically reliant on one or two basic products, upon which a majority of the national work force depends. An imbalance of devastating magnitude like this volcano or similarly, a hurricane, or tidal wave can cause losses in life and property but it all comes uninformed so what can one really do about it?

Members will be happy to know that our exclusive B2B travel & tourism exhibition ITTE - India Travel Trade Expo which was deferred from February 18th is now scheduled to be held on 7th and 8th August, 2010 at the World Trade Center, Cuff Parade, Mumbai. Tourism figures are expected to go up this year after last year's dismal performance with the economic downturn so the ITTE in the 2nd quarter of 2010 will be the right medium for adopting stimulus measures to shore up the tourism industry.

We are also looking at several destinations to host our Indian Travel Congress, 59th Convention & Exhibition of TAAI and as soon as we decide the venue, details shall be flashed to you.

Also we shall have to await news on the response from those airlines who have gone to zero as TAAI has written to each and everyone of them and this too shall be intimated to you immediately on receipt of any communication from their end.

Travel Associations' Conclave-A Huge Success

Even a month after the Director General of Civil Aviation (DGCA) issued an order (March 5) mandating all airlines operating to/ from and within the country to pay a fair commission to accredited travel agents, the airlines that have gone to zero have not come forward to pay the same.

Thereafter, an All Travel Association Meet (TAAI, TAFI, IATO, ADTOI, ETAA and IAAI) was held on 5th April, in Mumbai to discuss the future course of action.

Rajinder Rai, President, informed a packed hall of reporters, that the associations were not going to adopt any aggressive means to get their rightful dues. "It has been one month since the order has been passed." Said Mr Rai " and we are here to chart out our future course of action. We would be sending them letters and through consultations and meeting that we plan to come to a solution." The DGCA in its order has not specified the quantum of commission to be paid to the agents. Instead, the aviation sector regulator has left it to be thrashed out through negotiations between the travel agents and airlines. " Since the zero commission system is loaded with a transaction fee, the consumer has to pay extra money." Said Mr Sunil Kumar, Hon Secretary General.

The association representatives would be negotiating with all the 15 international operators separately. There was a large turnout of media leading to excellent press coverage the next day.

Important Meeting with the Chief Passport Officer

Our Chairman for Allied Services Council, Ranjit Vig had a fruitful meeting with Mr. A. Manickam, CPO at his office alongwith colleagues Mr. P. Murugesh Co opted M C Member and Mr. Imtiaz Qureshi, Chairman, Andhra Pradesh Chapter, on 06th April.

The CPO was presented with a brief note recapping the pending issues after which he reaffirmed the commitment of the Passport Offices in India to the Travel Agent Community and reiterated that they are an integral part of our industry ,therefore need a ongoing interface between them and the general public (customers). Mr Manickam updated our team on the successful progress of the pilot on the PSP launched in Bangalore & Chandigarh and that the implementation of other locations is being planned soon in order to provide easy access to the public to reduce the harassment faced by the applicants. We discussed with him the opportunity to collaborate on this initiative and recommended, that the Passport Offices seek valuable support of our approved TAAI agents , who are honorable members and are synonymous with our TAAI motto of "Deal with some you can trust" .

It was further conveyed that recognition of TAAI agents by Passport Offices reinforces the documentation checks for further verification in the process adopted. We also re-emphasized, that a formal approval be granted to the TAAI agents to represent the Passport

Offices in accepting applications online for processing as this would bring valuable recognitions to our membership, as we would be seen as the authorized agents of the Passport Offices by the applicants. The CPO took a positive view of our good suggestions and expressed he would share the same with his team for consideration. He also updated us on the E-Passport Introduction and advised that the initiation of the same would happen during course this year.

The concerns of our Region/Chapters were briefed to him and he assured to look into those. He also conveyed, that he would speak, to the RPO at Hyderabad and address the A.P Chapter concerns on priority . Mr Manickam welcomed an ongoing interaction with the TAAI Members for sharing our concerns in mutual interest, however the same he wanted these to be routed though the appointed management team dealing with the subject matter.

Last but not the least, the Allied Council committee appreciates receiving responses from a few Regions / Chapters on their concerns which have been shared with the CPO . It is requested, that other Chapters / Regions should also share their experience to enable us enhance a more potent meeting with such senior audience which will help us address basket of issues faced nationally by our members.

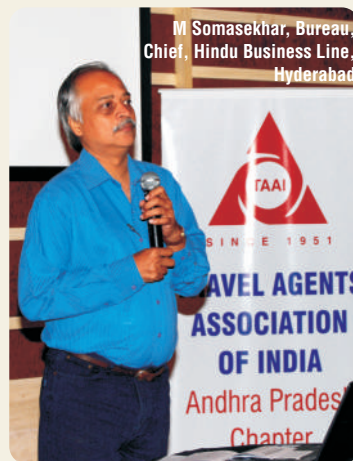

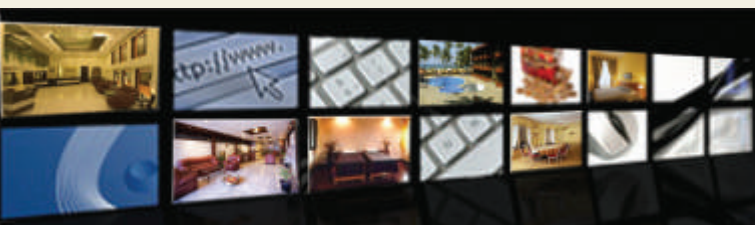
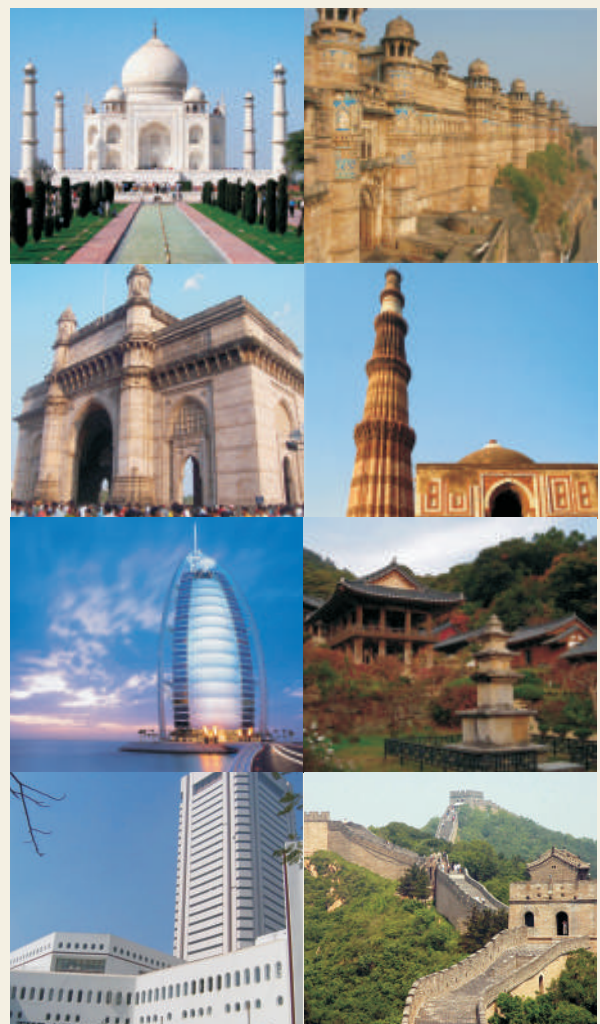
